Sealed quotations are herewith invited by SJVN Lower Arun Power Development Company Pvt. Ltd. TERMS & CONDITIONS (T&C):

1. Eligible Bidders

- (i) This Invitation for Bid is open to all the bidders registered in Nepal who meet the Qualification Criteria as defined hereunder.
- (ii) Bidders should not have as an individual or as a partner in JV banned/ de-listed/ black-listed/ debarred from business by any PSU/Govt. Deptt. /SLPDC during the last 03 (three) years on grounds of corrupt/fraudulent practices and/or on any ground. An undertaking to this effect shall be furnished by the bidder as per the format attached Annexure-‘E’.

2. Minimum Qualifying Requirements:

- i. Average Annual Financial turnover during the last 3 years, ending 15th July, 2025, should be at least **NPR 1,20,956/-**
- ii. Experience of having successfully completed/Ongoing following similar works as Prime Contractor or JV member or approved sub-contractor during the preceding seven years to be reckoned from the last day of the month previous to the one in which NIT is invited:

Three similar completed/Ongoing works costing not less than **NPR 1,61,274/-** (Including VAT) each.

or

Two similar completed/Ongoing works costing not less than **NPR 2,01,593/-** (Including VAT) each.

or

One similar completed/Ongoing works costing not less than **NPR 3,22,549/-** (Including VAT) each.

Similar work means works involving "Design & development of website with features of Content Management System/ Maintenance of website(s) for a period of one year".

The value of the work to be considered shall be the cost arrived for the period completed upto the last day of the month previous to the one in which NIT is invited. Further, period of maintenance shall also be considered up to the last day of the month previous to the one in which NIT is invited. In case work has been executed as JV, value of the work executed shall be considered in proportionate to percentage participation in JV.

The bidder shall submit copies of award letter along with successful completion/Ongoing certificate from the agency/firm for which work is executed in support of above experience condition and Balance Sheets and /or Audit Reports and/or tax clearance certificate obtained from the Inland Revenue Department or documents showing submission of tax returns for the last 3 years, ending 15th July 2025 in support of meeting turnover requirements.

iii. Bidders intending to participate in Joint Ventures are not allowed to participate.

3. **Submission of Bid: -**

The bidder must submit the bid in the following **two separate sealed envelopes {PART-I (Envelope-1) & PART-II (Envelope-2)}** clearly indicating the contents therein duly super scribed as under and these two envelopes should be enclosed in a single sealed envelope/cover super scribed as **“Annual Maintenance of website, hosting of 10 GB webspace & SSL of corporate website (www.slpdc.com.np) of SLPDC, Sankhuwasabha, Nepal. (PPR-09/2026)”** and submitted at the address of the undersigned (Satluj Bhawan, Arun Sadan, SLPDC, Tumlingtar, Distt. Sankhuwasabha, Nepal) and must reach this office through courier or by post or by hand on or before **by 19.05.2026 1530 Hrs.** and same shall be opened on **19.05.2026 at 1600 Hrs.** in presence of authorized representative of firms who choose to attend.

Further, In the “Techno-Commercial” part *{i.e. in PART-I (Envelope-1)}* of the bid the bidder shall not give any indication about the bid price in any manner whatsoever. Non-compliance of this provision may result in the rejection of bid.

- viii. Related Party Declaration (Third Party / Counter Party) as per Annexure-F.
- ix. Related Party Declaration-Employee as per Annexure 'G'

PART-II (Envelope-2): -

Price bid: - Comprising of Price Bid at Annexure-A i.e., duly filled, signed and stamped in Bill of Quantities (BOQ).

4. **Opening of Bid:** -

The bid shall be opened in the following sequence: -

- i. First, the envelope Part-I shall be opened.
- ii. Part -II (Price Bid) shall be opened subsequently, if no clarification is required from the Bidder(s). In case clarification is sought from the firm(s)/agency(ies), separate intimation shall be given through notification on the websites for opening of Price Bid(s) of responsive bidder(s).

5. **Contract period:** The Contract period shall be for a period of 2 years to be reckoned from date of issuance of Letter of Acceptance (LOA).

The Contract period may be extended on the same rates, terms and conditions for a period of another 01 (One) year subject to satisfactory performance certification by OIC.

Migration Period: 15 Days from the date of issuance of LOA (for new vendor).

6. **Bid Validity:** The bid (s) shall be valid for 90 days from the opening of bid(s).

7. **Prices:** - The bidder shall offer rates & prices "on Firm Price Basis". The rates quoted under **Annexure-A 'BOQ'** should be inclusive of VAT complete as per scope of work and nothing extra shall be payable by SLPDC on account of above.

Further, only unconditional discount offered at appropriate place in the BOQ shall only be considered for evaluation of the bid, discount offered at any other place or in any other document/letter submitted by the bidder along with the bid shall not be considered for the purpose of evaluation as well as award. Further, the bidder shall quote rate and amount inclusive of VAT, any other charges/taxes/VAT mentioned at any other place/document/letter by the bidder/supplier shall also for not be considered evaluation as well as award.

8. SLPDC reserves the right to adjust arithmetical or other errors (if any) noticed in the quotation as follows:

- i. Where there is a discrepancy between unit rate in figures and in words, the unit rate in words will govern; and
- ii. Where there is a discrepancy between the unit rate and the line item total resulting from multiplying the unit rate by the quantity, the unit rate as quoted in words will govern.

In case error due to wrong extension of quantities, the quantities as specified in the NIT/NIQ will be considered and multiplied by the unit rates quoted in words to obtain the amount.

The amount stated in the Bid will be adjusted by the SLPDC in accordance with the above procedure for the correction of errors and shall be considered as binding upon the bidder. If the bidder does not accept the corrected amount of bid, his bid will be rejected.

9. **Payment:** The payment will be made in the following manner:

- i. **For BOQ item at Sr. 1 i.e. AMC of Corporate Website (www.slpdc.com.np)**, Payment shall be made half yearly on submission of Invoice complete in all respect and certification of work to the satisfaction of the Engineer/Officer-in-charge.
- ii. **For Sr. 2 & 3 of BOQ, i.e. Hosting and SSL renewal of Corporate Website (www.slpdc.com.np)**, Payment shall be made after its renewal on yearly basis and issuance of work satisfaction certificate by Engineer/Officer-in-charge and on submission of invoice.
- iii. **For Sr. 4 of BOQ i.e. Migration Charge**, Payment shall be made after migrating the data and issuance of work satisfactory certificate by Engineer/Officer-in-charge and on submission of invoice (For new vendor only).

10. **Earnest Money Deposit (EMD):**

- a. Earnest Money Deposit (EMD) amounting to **NPR 8,100/-** shall be submitted in the shape of **Bank Draft** (in original)/**Manager Cheque** (in original) in the name of **SJVN LOWER ARUN POWER DEVELOPMENT CO. Bidders are advised and shall be responsible to ensure the receipt of net amount (excluding bank transfer charges) in above account in case of Indian bidder before last date of submission of bids.

However, if Bidder/Firm opt for submission of Earnest Money Deposited (EMD)/Bid Security directly in the bank account of SLPDC, then the documentary evidence/ proof of same (swift statement/ transfer statement/ account statement) has to be submitted along with technical bid in Part-I.

Any bid not accompanied by an acceptable Earnest Money Deposit shall be declared non-responsive and outrightly rejected by the Employer and their Part-II (Price Bid) bid shall not be opened.

- b. EMD of the bidder shall be forfeited:

- i. If bid withdrawn or amends its bid or impairs or derogates from the bid in any respect in the interval between the bid submission deadline and the expiration of the bid validity period.

or

- ii. Adopts corrupt or fraudulent practices.

or

- iii. Does not accept the correction of the Bid Price.

or

- iv. EMD of the successful bidder(s)) shall be forfeited, in the event of non-compliance of Letter of Acceptance (LOA).

or

- v. fails or refuses to furnish the Performance Security, in accordance with the NIQ/LOA.
- c. Bidder may modify or amends its bid or withdraw its bid after submission and before the prescribed deadline for bid submission.
- d. The EMD of unsuccessful Firm(s)/Agency(ies) shall be released within 30 days without any interest after declaration of non-responsive. Further, EMD of responsive bidders (other than L1 bidder) shall be released within 30 days without any interest after the issuance of Letter of Acceptance of successful Firm(s)/Agency(ies).
- e. The EMD of the successful bidder shall be released within 28 days after submission of performance security, required to be submitted in terms of NIQ Clause 13.
- f. No interest shall be payable by SLPDC on EMD.

11. **Award Criteria:**

- (i) The bid shall be evaluated on overall basis and the award shall be made based on the lowest rate/Amount quoted by the Bidder/Supplier for whole work/assignment as per **Annexure-A** in the Bill of Quantities provided evaluated bid price is within reasonable variation of estimated amount of work.
- (ii) If, Bidder(s) quote Zero/Nil/left Blank/(-) rate(s) against any item(s) of BOQ then it will be presumed that bidder(s) has/have quoted the rate(s) for that item(s) in any other item(s) of BOQ. In that case Zero (0) rate(s) shall be considered for the purpose for evaluation as well as award.

12. **Liquidated Damages (LD):** In case of delay in response on emergency call service (i.e. after 24 hrs. from the intimation through call/email) compensation amount @ NPR 1000 per occasion shall be deducted and subject to maximum 5% of Contract Price.

13. **Performance Security Deposit:**

13.1 Within 28 (twenty-eight) days from the date of issue of the Supply Order/Letter of Acceptance (LOA), the successful bidder(s) shall deliver to the Employer a Performance Security equal to **5% (five percent)** of the Contract Price valid till 60 days beyond Contract period.

13.2 The Performance Security Deposit shall be in one of the following forms:

Bank Draft (in original) /Manager Cheque (in original) in the name of **SJVN LOWER ARUN POWER DEVELOPMENT CO. PVT LTD** payable at Khandbari, Nepal.

Or

FDR (in original) (duly pledged in favour of **SJVN LOWER ARUN POWER DEVELOPMENT CO. PVT LTD**).

Or

An irrevocable valid and fully enforceable Bank Guarantee (in original) from a Commercial (Class A) bank of Nepal in favour of **SJVN LOWER ARUN POWER DEVELOPMENT CO. PVT LTD** acceptable to SLPDC. The said Bank Guarantee should be as per the format provided in tender document, which shall be valid till **60 (Sixty) days beyond contract completion period**.

13.3 Failure of the successful Bidder to comply with the requirements of Clause 13.1 shall constitute sufficient grounds for cancellation of the award and forfeiture of the Earnest Money Deposit. He may also be debarred from participating in bids invited by the Project for one year.

- 13.4 The performance guarantee will be returned by the EIC (Engineer-in-Charge)/Officer-In-Charge (OIC) to the contractor/Supplier within 28 days after completion of contract without any interest, after issuance of successful Completion Certificate.
- 13.5 In case of delay in submission of performance security beyond 28 days as provided in clause 13.1 above, interest @ SBI, India one-year MCLR +200 Basis points applicable on the date of bid submission shall be charged on per day basis up to the date of delay in submission. However, delayed acceptance beyond 56 days shall be at the sole discretion of SLPDC and Letter of Acceptance/ award (LOA) shall be subject to cancellation and forfeiture of EMD along with other suitable action as per NIQ.
- 13.6 In case, the last day of submission of Performance Security happens to be a bank holiday, the last day of submission shall be the next working day.
- 13.7 The notification of Award (NOA)/Letter of Acceptance (LOA) will constitute the formation of the Contract and further subject only to the furnishing of a performance security.
14. **Force Majeure:** The term "Force Majeure" shall herein mean riots (other than among the Vendor's employees), Civil Commotion (to the extent not insurable), war (whether declared or not), invasion, act of foreign enemies, hostilities, civil war, rebellion, revolution, insurrection, military or usurped power, damage from aircraft, nuclear fission, acts of God, such as earthquake (above 7 magnitude on Richter Scale), lightning, unprecedented floods, fires not caused by Vendor's negligence and other such causes over which the Vendor has no control and are accepted as such by the Officer-in-Charge (OIC), whose decision shall be final and binding. In the event of either party being rendered unable by Force Majeure to perform any obligation required to be performed by them under this contract, the relative obligation of the party affected by such Force Majeure shall be treated as suspended for the period during which such Force Majeure cause lasts, provided the party alleging that it has been rendered unable as aforesaid, thereby shall notify within 10 days of the alleged beginning and ending thereof giving full particulars and satisfactory evidence in support of such cause.

Extension of time without levy of LD shall be provided during the period of occurrence of Force Majeure event, however no cost compensation shall be provided.

16. **Resolution of Dispute:** In case of any dispute or difference that arises out of the subject cited supply, the same shall be referred to the Sole Arbitrator, who shall be appointed by the CEO, Lower Arun HEP, SLPDC, Tumlingtar. The award of the arbitrator shall be final and binding on both the parties.

Courts of Chainpur (Nepal) shall have exclusive Jurisdiction for adjudication upon the dispute arising out of the subject cited supply between the parties.

17. Corrigendum/Addendum, if any to NIQ shall be uploaded only on <https://sjvn.nic.in> and <https://slpdc.com.np>. The bidders may keep watch on the said portals.
18. SLPDC reserves the right to reject any or all the tenders without assigning any reason thereof.
19. The bidder shall be deemed to have inspected and examined the site/area and its surroundings and collected information available in connection with and to have satisfied himself, before, submitting his bid, as to the form and nature thereof, including the subsurface conditions, the hydrological and climatic conditions, the extent and nature of work and the means of access to the site and, in general, shall be deemed to have obtained all necessary information, subject as above mentioned, as to risks, contingencies and all other circumstances which may influence or affect his bid.

Access to Project Sites:

To reach the site of Lower Arun HPP Nepal the nearest broad-gauge railway station is Jogbani, Bihar (India) and further by road up to Tumlingtar is about nearly 264 Km. Jogbani in Bihar is a city of India with Nepal border and is just 6.00 Km. from Biratnagar (a major industrial town of Nepal).

Road conditions in different road segment en-route are as under:

- Jogbani to Hile: - Hile is located at a distance of 118 Km from Jogbani and the existing road up to Hile is black topped road. Hile is at EL 1920 m from sea level.
- Hile to Tumlingtar (Hill road route): - This route is about 111 Km and the road is black topped up to Tumlingtar.
- Tumlingtar is also connected to Kathmandu by air by around thirty-five minutes' journey.
